



## ENROLLMENT AGREEMENT

**PLEASE NOTE:** To reach their academic goals and prepare for future educational experiences, students enrolling in MDVS must comply with the following requirements and expectations to remain enrolled:

### ACADEMIC PERFORMANCE

- Maintain an overall grade point average of 2.0 in all courses. A final grade of "F" in any course may result in the student being withdrawn from MDVS at the end of the school year.
- All students are to adhere to State Mandates for in-person testing and are required to come in person to take mandatory state assessments.

### ATTENDANCE

- Maintain school attendance per School Board Policy 5200, which states that a student may not accumulate more than ten (10) unexcused absences in an annual course or more than five (5) unexcused absences in a semester course.
- Have or obtain working internet and device to always log in to all classes with the camera on and use headphones.

### BEHAVIOR AND CONDUCT

- Violation of the Miami-Dade County Public Schools Code of Student Conduct may result in probation or possible immediate withdraw from the program. <http://ehandbooks.dadeschools.net/policies/90/index.htm>
- Students are to attend classes appropriately groomed and dressed while attending classes.
- Excessive referrals will result in a behavioral contract, probation, and possible withdraw at the end of the school year.
- Students who violate Level III, IV or V of the Code of Student Conduct or have been assigned to an alternative setting will not be allowed to return to MDVS.
- Parents or Guardians must provide on-site supervision and support to students as well as monitor student grades and progress.

If a student has not shown sufficient progress or fails to meet requirements at any time throughout the school year as outlined above, the student will be placed on probation as follows:

- **PARENT NOTIFICATION** - Parent/Legal Guardian will be notified of insufficient progress or failing to meet academic standards via progress report, report card or via email.
- **PROBATION CONFERENCE** – Parents of students not meeting requirements will be notified via email or will meet with assigned school staff as designated by the principal to assist the student. At this time, the student will be placed on probation. Parents and students are to check emails regularly for notification.
- **WITHDRAWN FROM PROGRAM** - If a student fails to meet the above listed criteria by the end of the semester, the student will be withdrawn from MDVS and may enroll at their boundary school.
- Once a student is withdrawn, whether voluntarily or due to failure to meet agreement requirements, he/she cannot be re-enrolled in MDVS during the same school year. All withdrawals are final and binding. A student may reapply during the application period for the following school year (excluding Levels III, IV or V Code of Student Conduct Violations).

We have read the MIAMI DADE VIRTUAL SCHOOL Enrollment Agreement and understand the requirements for continued enrollment.
