Teachers will receive credit for classroom teaching experience or non-teaching experience per the M-DCPS/UTD Contract Appendix E, not to exceed the base salary of a continuously employed Grandfathered M-DCPS teacher with the same years of experience.

Teachers with Advanced Degree Credentials (Master's, Specialist, Doctorate), must complete the Application for Credential Payment for Advanced Degrees form (FM-2095)** to receive payment.
