Issues we continue to propose and work towards:

- **Ethics Commission for the School Board.** This measure has received the help and support of The Alliance of Ethical Government under the direction of Chief Justice Gerald Kogan, the League of Women Voters and The Westchester Homeowners Association, just to name a few organizations. Hopefully, the board will have some incipient plans underway by October 2001.
- **Office of Inspector General for the School Board.** Based on the success of the county Inspector General, as well as the conjunction with the Ethics Commission, have subpoena powers, and fortify the School Board's measures of accountability and reform.
- **Evaluation of the Superintendent and Attorney.** The only employees accountable to the School Board are the Superintendent and the School Board Attorney. Conducting annual evaluation of these two employees further enhances our accountability goals.

Our office works in earnest **to make our school system the best in the nation.** Our focus for the future continues to be **academic excellence, thrift and accountability, student safety, overcrowding, early childhood education** and many others. We put all our efforts into improving our school system.
