REQUEST FOR APPROVAL OF RESOLUTION NO. 00-02 OF THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, SUPPORTING FEDERAL GOVERNMENT INITIATIVES THAT PROVIDE LOCALLY CONTROLLED FUNDING FOR SCHOOL CONSTRUCTION AND RENOVATION

Miami-Dade County Public Schools continues to lack adequate school facilities to house its rapidly growing student population despite the bond referendum passed in 1988. And, the probability of passing another bond referendum in Miami-Dade County is unlikely. This presents the Board with the unique challenge of finding alternate sources of funding to accommodate the ever-increasing number of students entering our school system each year.

A solution to meeting the needs resulting from our school district's continued growth is federal and state funding that can be controlled locally by the School Board to ensure that it is distributed where it is most needed. Because of the nation's healthy economy, Congress has a rare opportunity to create a new partnership between the federal government, states and communities to improve the learning environment for our children.

General measures supported by this item are the direct allocation of allowable tax credits to large school districts and the expansion of the Qualified Zone Academy Bonds which provide funding for schools that are within an empowerment zone or enterprise zone, or schools that have thirty-five percent or more students participating in free and reduced-price lunch programs. The inclusion of these provisions in federal education appropriations bills will greatly benefit this school system by helping achieve the goals of smaller class sizes and more personalized education for all.

WHEREAS, smaller class sizes and more personalized education for all will be more attainable through local control of federal funding;
