At the Board meeting of June 16, 2010, The School Board of Miami-Dade County, Florida, approved Agenda Item C-3, requesting that The School Board of Miami-Dade County, Florida, receive a status report on the feasibility of creating a pilot program that incorporates Baby Care (0 - 3 years) for children of school employees at designated school sites and district buildings.

The feasibility report included four implementation models and an implementation timeline, as follows:

### Phase I: 2010 - 2011

Model A: High Schools/Education Centers

Five licensed senior high schools will offer a baby care and education program at Miami Lakes Education Center, Booker T. Washington Senior High School, Coral Gables Senior High School, Lindsey Hopkins Educational Center, and Miami Sunset Senior High School.

• Model B: Public/Private Partnership by Feeder Pattern

Accredited and licensed private child care centers within specific feeder patterns will partner with Miami-Dade County Public Schools' Office of Early Childhood Programs to provide child care services with preferential courtesy rates for District employees.

#### Phase II: 2011 – 2012

# Model C: Alternative Public/Private Partnerships

Classroom space in under-enrolled schools will be leased to agencies or entities such as the United Way, Child Development Services, and the Miami-Dade Community Action Agency Head Start to provide services for children birth to three years of age.

## Model D: Elementary Schools Center

Two under-enrolled elementary schools will offer a fee-based Baby Care and Education Program for three year old students. Potential sites are Tropical Elementary and Orchard Villa Elementary.

### Phase III: 2012 - 2013 and Beyond

Continue the expansion of age birth through three programs at under-enrolled elementary schools based on the availability of space and need.
